



## **Enrollment/Waitlist Fee:**

\$200, per child

All families who wish to reserve a spot, whether they are offered an immediate opening or placed on our waitlist, must pay an enrollment fee of \$150, per child, and complete all enrollment paperwork. If an opening is available at this time, a family will also be asked to pay for their first week of tuition and must start within 30 days. If there is not immediate availability, a family will be placed on the waitlist, once their enrollment paperwork has been completed and the enrollment fee has been received. Waitlisted families are provided with an estimated start date, and a member of the SSLC administration team will reach out approximately 30-60 days prior to the estimated start date to offer a guaranteed start date. Waitlisted families will have 48 hours to accept or reject an offer and must pay the first week of care within 3 business days, or the offer is rescinded. Families may choose to reject an offer, thus moving them to the bottom position on the waitlist.

## **Annual Supply Fee**

\$115 per child

Required for all enrolled and currently attending children, and is invoiced the first Monday in September

## **Regular Care Tuition Rates: Care Between 8am-5pm**

\*Sibling are available for full time enrollment only

### Infant/Toddler Tuition:

Monday through Friday, full time only offerings for children under the age of 3

\$470/week

### Preschool Tuition:

For children ages 3 and up, Full time and Part time. For 4 year olds, see additional UPK enrollment details

## **Before and After Care & Drop-In Care**

To gain access to the hours of 6:45-8:00am, as well as 5:00-6:00pm, enroll in before and after care for an additional \$6/per day (per child). Before and after care must be arranged, in advance, and with enrollment selections submitted, and approved, prior to the start of the week. Drop in before and after care is an additional \$35 per day. Drop-in/Add-on Full Days are \$90 each, due the day drop-in care is received. Drop-in care spots are based on availability, and openings are not guaranteed.



## Universal Preschool- 2023/2024

All Colorado children are eligible for UPK Colorado in the year before they become eligible for kindergarten. CDEC uses a cutoff of October 1, meaning that a child who turns four before this date in the year they wish to enroll in preschool will be eligible for UPK Colorado. Starting the first Monday in September of each school year, and ending at the close of the school year (last week in May), families with 4 year olds who qualify for Universal Preschool (UPK), and who have successfully applied and received UPK placement at SSLC, will receive a tuition credit. The amount of this credit is dependent on the amount of approved UPK hours, and the current UPK rate. Most families who are enrolled in UPK will receive a credit equal to 15 hours, and will be required to pay the remainder of the tuition costs for full day wrap care and education (care outside of the 15 hours that UPK provides). At this time, UPK will provide a weekly stipend from September 4, 2023-May 31, 2024, paid directly to the center, as follows:

For 4 year olds approved for 10 hours: \$157.13

For 4 year olds approved for 15 hours: \$196.35

For 4 year olds approved for 30 hours: \$350.45

2024/2025 tuition and wrap care rates will be released once the UPK tuition rates have been shared with providers.
